#### **SYNTHESIS**

### 1. OBJECTIVE OF THE CALL FOR EXPRESSIONS OF INTEREST

- The Government of Santa Fe Province and Santa Fe Port Administration Body call national and foreign investors to participate in the Process of Expressions of Interest for the: Formulation of the Executive Project, Construction, Maintenance and Operation Licence of the Project of Santa Fe Port Restructuring, by which the Applicants who have expressed their interest and pre-qualified will be able to propose modifications, to make additions, suppressions or changes to the Preliminary Documents by the Data Room process, before the Government of Santa Fe Province publishes the Final Bidding Terms and Conditions.
- ✓ Interested investors shall request the Bidding Terms and Conditions to the call for Expressions of Interest by the model note provided in Annex I.
- ✓ In order to pre-qualify, interested investors shall participate in a pre-qualification process, by sending the documents to fulfil legal, business and economic-financial requirements before 30<sup>th</sup> September. Those who pre-qualify will take part in the Data Room process.
- ✓ Participation in the Expressions of Interest and Data Room process does not grant the applicants any preferential right to take part in the Investment Stage. Likewise, those enterprises willing to participate in the National and International Public Tender are not obliged to participate in the present Call.
- During the Data Room process, pre-qualified investors will have access to existing information. At this stage, suggestions for the project of Bidding Terms and Conditions to the Call for National and International Public Tender, as well as for the Preliminary Draft made by Santa Fe Province based on the study performed by the Regional Integration Consortium COINRE..
- ✓ The Government of Santa Fe Province will proceed to write the final documents of the Bidding Terms and Conditions to the Call for National and International Public Tender, and once the authorization of FONPLATA (Financial Fund for the Development of Rio de la Plata Basin) is obtained, it will call for bids.

A summary of last Balance with report issued by Certified Public Accountant in domestic and foreign currency, bearing the following items:

Assets: Disposable Assets, Credits, Investments, Liquid Assets, Other Assets. Total Current Assets. Fixed Assets, Investments, Other Non-current Assets, and Total Non-current Assets. Total Assets.

Current and Non-current Liabilities. Total Liabilities.

Equity: Capital, Reserves and Profits. Total Equity.

- ✓ Subscribed and paid-in capital to date of last balance, with an Equity equal or superior to two million pesos (\$2,000,000).
- ✓ Documents on business capacity such as:

Background record, type of activity, business amounts, permanent staff, areas of operation, performed projects, etc.

In case of having experience in port business, the interested party will provide details of ports, terminals or docks which he operates or has operated with, their characteristics, and the date of beginning of operation.

- ✓ Articles of Association or Partnership Contract.
- ✓ Complete details of board of directors or equivalent.
- ✓ Directors minutes supporting the decision to apply for the Call for Expressions of Interest.
- ✓ Legal status of the representative or agent.
- ✓ Company responsible agents who are liable to participate in the project.
